Sir/Madam,

This is with reference to the proposal submitted by Vishnu Institute of Technology, Vishnupur, Bhimavaram-534 202, Andhra Pradesh affiliated to JNTU, Kakinada under the UGC Scheme for Autonomous Colleges.

The Standing Committee in its meeting held on 16.01.2019 decided to grant autonomous status to Vishnu Institute of Technology, Vishnupur, Bhimavaram-534 202, Andhra Pradesh affiliated to JNTU, Kakinada for a period of ten years w.e.f. 2019-2020 to 2028-2029.

The University is requested to issue necessary notification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.



2. Note orders dated 28.2.2019 of the Hon'ble Vice – Chancellor , JNTUK Kakinada.

In the letter under reference, the UGC, New Delhi has communicated the conferment of Fresh Autonomous status to "*Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh*" for a period of ten years i.e., from the Academic year 2019-20 to 2028-29.

In this connection, I am by direction, wish to endorse the orders of the UGC regarding conferment of Fresh Autonomous status to "*Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh*" from the Academic year 2019-20 to 2028-29, subject to fulfillment of the following conditions:-

- a. "*Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh*" shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- b. The students presently enrolled in the "*Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh*" shall continue to be governed by the academic regulations of JNTUK Kakinada.
- c. The admission procedures to be followed by the "*Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh*" shall continue to remain the same as those of APSCHE/JNTUK for various programs run by it even after acquiring autonomous status.

- d. *The autonomous status for the "Vishnu Institute of Technology, Bhimavaram, West Godavari District, Andhra Pradesh" shall come into force with effect from the academic year 2019-20.*
- e. *The college shall follow the guidelines issued by the UGC in all matters.*
- f. *The college shall constitute the necessary Statutory Bodies and inform the University.*
- g. *There shall be no financial commitment on the part of JNTUK Kakinada and the college shall continue to pay all administrative/affiliation fees due to the University as usual.*
- h. *As by UGC the college may reapply for extension of autonomous status six months prior to the expiry of the autonomous cycle.*
